1. TRUST FUNDS :

(i) That the Author of the Trust through this Trust Deed has Settled a sum of Rs. 1,01,000/- only in favour of Trustees mentioned here in above for the purposes of the Trust. The Trustees shall utilize the trust fund (including any Income, additions, accretions or accumulations whether in cash or in kind to the fund received in future as well) for achieving the aims and objectives of the Trust mentioned hereinafter.

(ii) That the Trust shall stand possessed of the aforesaid amount of Rs. 1,01,000/- only and such further capital endorsements or additions to the corpus or donations, Voluntary contributions, subscriptions or legacies in cash or in kind, as may be invited and received or received without invitation or accepted by the Trustees from time to time from any person or persons, institutions, government or members of public. And all accretions thereto and income thereof from all these receipts shall be treated as forming part of the trust fund being the subject matter of these presents.

2. NAME OF THE TRUST :

DEFINITIONS

In these rules and regulations, unless otherwise clearly stated in the context the following words shall have the meaning assigned to them here-in-after as follows :

- (i) Trust shall mean **VIDYA NIKETAN EDUCATIONAL TRUST**
- (ii) Board of Trust shall mean all the Trustees of the Trust constituted according to the rules of the Trust.
- (iii) Member or Trust shall mean a person whose name appears in the register of the Trustees of the Trust.

MEMBERSHIP :

- (i) There shall be the following nature of Trustees / memberships :
 - (a) **First Trustees** : The Trustees who have signed the **DECLARATION OF THE TRUST**.
 - (b) **Ordinary Trustees / Members** : Members other than First Trustees shall be called as Ordinary trustees / members. They shall become the members of the Trust on approval of their name by other trustees and by paying a nominal sum as Membership Fees which shall be decided by the Board of Trustees from time to time.
 - (c) **Honorary / Patron Members** : Those persons to whom the Board of Trustees thinks fit and proper and whose association shall be deemed beneficial to the Trust, in achieving the objectives of the Trust. Their term shall be or at the discretion of the Board of the Trustees of the Trust.
- (ii) The first Trustees shall be the members of the Trust for their whole life. The membership of the Trust is not transferable. However the Author of the trust can nominate any person of his choice in his place. In case of death of any of the **FIRST TRUSTEES** of the Trust, his / her membership shall be inherited by the legal heir of such person as nominated by him / her, if any. If no such nomination has been done then any ONE of his dependent legal heir as approved by all the remaining Trustees, shall become the member of the Trust and thus nominated person / legal heirs so appointed shall have all the rights and privileges as were enjoyed by the First Trustees including nomination of his dependent family members and inheritance right to his dependents. These Trustees shall also not be liable to pay the annual membership Fees of the Trust.

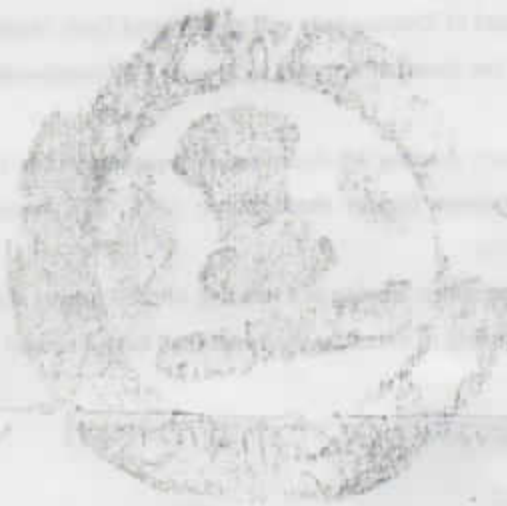

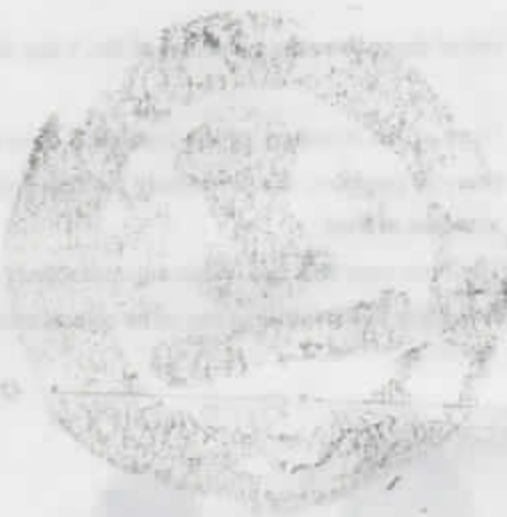
